# Main objective of the MoU

The main objective of this MoU is to provide a framework for cooperation in connection with a pilot program on pupil exchange at the upper secondary school level.

## Organizations which may be included in the framework of the MoU:

The signing organizations and the upper secondary schools designated by the signing organizations for implementing the pupil exchange may be included.

## The objectives and means of action:

The main objectives of the project are to enable the pupils to:

- discover another educational system
- discover another culture
- improve their language skills
- strengthen informal competences

## The means to reach these objectives would be:

- The inclusion of the pupils within an upper secondary school.
- The cultural immersion in a host family.

## Organization of the pilot project:

The upper secondary schools should be delegated the necessary authority to organize and implement the project. The upper secondary schools should have full responsibility for the implementation of the project.

## Financing:

The organization of the project should comply with the following conditions:

- The financing of the project is based on the principle of strict reciprocity between the actors.
- The upper secondary school which hosts a foreign pupil should cover the possible expenses required to include the pupil in the school establishment and in the teaching. This includes, among other elements, monitoring and teaching materials.
- The host family should cover the necessary expenses connected to hosting a foreign pupil.
- The actors in the sending country should finance travel and insurances expenses.
- In the event of an accompanying person being sent with the pupils, the coverage of the expenses would be the sending country's responsibility.

## The accreditation of competence:

The accreditation of the mobility into the national curriculum is the responsibility of the actors of the sending country.

# The duration and dates of the project:

The duration of the mobility should be 4 weeks and should take place within the school year 2014-15. The project can be renewed in case of common agreement.

## The target group:

Pupils in the second year of general study at the upper secondary level constitute the target group.

## The contractual issues:
